



## **Clinical Leadership Role for the national Myocardial Ischaemia National Audit Project 1 PA per week\***

Do you have the passion and the skills required to lead the Myocardial Ischaemia National Audit Project (MINAP) to the next phase of quality improvement?

We are looking for a specialist consultant cardiologist or related specialty consultant to provide clinical leadership for the MINAP, a specialist domain of the National Cardiac Audit Programme (NCAP), managed by the National Institute for Cardiovascular Outcomes Research (NICOR). NICOR is hosted by NHS Arden and Greater East Midlands Commissioning Support Unit (AGEM) to deliver the programme which is commissioned and funded by NHS England. The appointment will be made by NICOR in consultation with the British Cardiovascular Society (BCS) using AGEM's recruitment process.

The position reports to the Director of NICOR and the Chair of the NCAP Operational and Methodology (NOM) Group. The post holder will work closely with the Chair of the NOM Group, NICOR Chief Operating Officer, other NCAP domain clinical leads and the NICOR delivery team. The post holder will:

- Chair multi-disciplinary MINAP Domain Expert Group (DEG) meetings, monthly project management team meetings and any other ad-hoc meetings, as required.
- Participate in monthly NOM Group meetings; and
- Act as an ambassador for NICOR.

The successful candidate will need to demonstrate professional excellence, an understanding of national audit and quality improvement methodology at a national level and the necessary management skills to ensure timely delivery of the agreed NCAP outputs, as well as to effectively develop and enhance the partnerships between NICOR and its stakeholders (professional societies, hospitals, commissioners, regulators, NHSE, patients and the public).
