

Publications



The annual report is supported with 10 interactive sub-specialty clinical reports with additional reference to the National Audit of Cardiac Rehabilitation. The interactive reports provide more detailed domain-level analyses and commentary allowing focus on the information that is of most interest to the reader (for example drilling down to explore the performance of different parts of the country and individual hospitals). Alongside the annual report, a dedicated Annual Report for Patients, Carers and the Public will be published. The 2025 annual reports will cover the 12 months from 1 April 2024 to 31 March 2025 (or between 1 April 2022 to 31 March 2025 for subspecialties that report on a three-year period).

Aortic dataset integration into NACSA

National Adult Cardiac Surgery Audit (NACSA) Aortic Dataset – v6 released.

We are pleased to announce the release of the <u>NACSA Aortic dataset (version 6)</u>. This updated version introduces an expanded range of aortic-specific fields, along with various enhancements and additions to the current dataset (v5.2.0).

Notable updates include the introduction of fields to support future EuroSCORE 3 calculations, as well as the inclusion of a Frailty Score. In anticipation of this release, please be advised that the v5.1.0 dataset is expected to be closed to further imports. It is essential that centres begin preparations to transition to the new dataset at the earliest opportunity. More information is available via the NICOR website: New dataset for NACSA.

Update on NICOR Data Access Requests: New process with NHS England
The submission process for NICOR data access requests has transitioned to NHS England and
is now managed through the central <u>Data Access Request Service (DARS)</u>.

Although administrative oversight is provided by NHS England, NICOR's involvement continues to be integral. At the initial stage, the NICOR team will provide subject matter expertise, assessing feasibility and ensuring appropriate project design. Thereafter, applicants will be supported through the administrative process by NHS England.

NICOR's data team will remain responsible for the preparation of high-quality data extracts for approved projects. This combined approach ensures continuity across both the advisory and technical dimensions of NICOR's contribution, thereby preserving the scientific and clinical value of the datasets.

NICOR granted Section 251 approval

NICOR has been granted approval under Section 251 of the NHS Act 2006 for all 10 audits and registries. Applications must be submitted to the Health Research Authority (HRA) Confidentiality Advisory Group (CAG) every 12 months for approval. Approval of Section 251 means NICOR can use patient identifiable data, without obtaining patient consent, for audit or medical research. This is vital for NICOR's work to enable hospitals and healthcare improvement bodies to monitor and improve the quality of care and outcomes of cardiovascular patients. Latest developments



EuroHeart collaboration

During the recent European Society of Cardiology (ESC) Congress in Madrid, the EuroHeart programme reported on developments in the collection and analysis of acute coronary syndrome (ACS) data. For the first time, this incorporated contributions from two major NICOR National Clinical Audits: the Myocardial Ischaemia National Audit Project (MINAP) and the National Audit of Percutaneous Coronary Intervention (NAPCI).

EuroHeart is an international registry initiative with the primary objective of defining and implementing standardised data frameworks for cardiovascular disease. The programme has established consensus-based data standards for ACS, enabling harmonisation of clinical information across participating countries. Future directions include the extension of these standards to additional cardiovascular domains, such as valvular heart disease and heart failure, to support cross-national benchmarking, facilitate comparative effectiveness research, and improve quality of care.

The continued success of EuroHeart and related initiatives is contingent upon both the robustness of the data collected and the sustained engagement of contributing centres and clinicians. The efforts of all participants are gratefully acknowledged, as their commitment underpins the advancement of collaborative cardiovascular research and quality improvement.

New study shows substantial variation in heart attack treatment

A new study using the National Institute for Cardiovascular Outcomes Research (NICOR) Myocardial Ischaemia National Audit Project (MINAP) data highlights substantial variation in how patients hospitalised at English hospitals are managed for acute myocardial infarction (AMI), particularly patients with non-ST-elevation myocardial infarction (NSTEMI) and reduced kidney function.

Analysing data from over 360,000 AMI admissions between 2014 and 2019, researchers observed variation in the use of invasive management strategies – namely, angiography, percutaneous coronary intervention (PCI) and coronary artery bypass graft (CABG) – versus conservative management. Patients with worse kidney function were notably less likely to receive invasive care, even after adjusting for other factors.

These findings highlight the need for further work to evaluate the comparative effectiveness of invasive versus conservative management strategies among people with reduced kidney function to reduce variation in care and improve outcomes for patients.
